



ROATÁN, HONDURAS

Roatán is the largest of the Bay Islands of Honduras, which are 30 miles (48 km) north of the mainland. Honduras is a popular vacation destination along its Caribbean coast and shares the Mesoamerican Reef, the second largest reef in the world. Roatán features the white sand beaches, coral formations, and marine biodiversity that are mainstays of Caribbean tourist destinations. Dive attractions include seawalls, shipwrecks, a submerged airplane, and night diving; the marine life includes sea turtles, dolphins, and whales. These features make for exceptional scuba diving and snorkeling experiences, as well as an alluring environment to beachgoers, fishers, and boaters.

Recognizing the economic value of tourism, Roatán is taking steps to further entice tourism and foreign development. The island has recently drafted, passed, and implemented laws that protect the environment and encourage foreign investment and ownership of property. In 2013, the Mesoamerican Reef Tourism Initiative led a comprehensive assessment and action plan for destination-level sustainability, supported by Royal Caribbean Cruises and Sustainable Travel International.

The Grande Club and Residences will join an existing 405-acre (164-hectare) luxury development, Pristine Bay Resort. The complex comprises two hotels, 392 residential resort homes—including a half-mile private beach—a top-ranked 18-hole golf course, and a beach club overlooking the second largest coral reef in the world. Pristine Bay Management Group manages the Beach Club and Residence Hotel, and the Houston-based Lancaster Group manages the Las Verandas 5-star boutique hotel, as well as six other hotels, of which three are corporately owned through various joint ventures.

Grande Property will complete the final phases of development with 400 residences—100 tennis villas and 300 Grande residences—and a Grande Racquet Club. These projects, built in harmony with the local tropical beauty, aim to sustain the resort's international appeal for generations to come. 



CITIZENSHIP BY INVESTMENT



Those who wish to live legally in Honduras for extended periods must receive permission from the Honduran government. Permits for residency in Honduras are processed in the capital city of Tegucigalpa by the Ministry of Interior and Justice (Secretaria de Gobernacion y Justicia), the Honduran governmental entity that oversees immigration issues. Therefore, finding a local attorney is mandatory as it's necessary for them to file your application. However, you may enter the country as a tourist and begin your application process while in Honduras.

An investor permit may be acquired if you are able to prove that your project is, or will be, represented by an investment of no less than \$50,000. You should also have a business plan and a feasibility study. The company has to be a registered Honduran company, plus you must make a deposit of \$5,000 in the Central Bank. Sometimes a property will be accepted in lieu of the deposit to guarantee the project.

The benefits of the CBI program include:

- Includes you, your spouse, and any children that are moving with you
- Can stay in the country longer than 90 days
- Able to bring all of your household items at once with a duty-free exemption
- No tax on income earned outside of Honduras
