



Grande Residences – Lisbon, Portugal

There is a plethora of airline companies operating at Lisbon Portela Airport, providing both business class and low cost flights to tourists around the world. Thus, the airport is the operation site of about 40 airline companies. ***By Railway:*** In terms of railway transport, the tourist and commercial platform of Lisbon is serviced by four main train stations: the Santa Apolonia (Estacao da Santa Apolonia), the so-called Rossio (Estacao do Rossio), Barreiro (Estacao do Barreiro) and Cais do Sodre (Estacao do Cais do Sodre).

Why Choose Lisbon? The adjacent Tejo River promenade spans over 10 acres in the Jardins de Braço de Prata. This diverse area recreates traditional Lisbon neighborhoods with a historical touch. The lively scene where the development is located is ready to offer various facilities including commercial and business centres to meet demands of different types of residents.
